Physical abuse may manifest with a wide range of signs and symptoms, from subtle bruising to significant traumatic brain or abdominal injury. Evaluating children who are suspected victims of physical abuse requires a multidisciplinary approach with collaboration between medical professionals, child protective services worker, and law enforcement. Medical findings, terminology, and biomechanics of injury may be very perplexing for non-medical community partners. Therefore, this pre-conference institute and APSAC conference lectures will cover the basics of child physical abuse including cutaneous lesions (bruises, bumps and burns), oral injuries, fractures, and internal injuries plus address advanced and emerging issues in the field through a review of the current literature.



Sex crime investigators, prosecutors, judges, probation officers, medical staff, child welfare workers and child/victim advocates should be familiar the theories about the etiology of pedophilia and the development of pro-offending attitudes, plus the typical patterns of sexual offending committed by juvenile and adult sex offenders. In addition, the presenter will review studies that examine the number of detected vs. undetected offenders and sexual crimes occurring in our communities and the average degree of "cross-over" or "crime switching" behavior sex offenders engage in. Video footage of interviews with sex offenders will also be used to examine some of the specific grooming strategies they used to target, seduce and exploit children and adults. The session will end by focusing on both research and anecdotal comments by admitting adult sex offenders and seasoned sex

The use of corporal punishment, a common form of discipline, is associated with many negative health outcomes and is a key risk factor for child abuse. Parents' attitudes toward and use of spanking are influenced by trusted professionals such as medical professionals, faith leaders, mental health professionals, teachers, parent educators, victim advocates, as well as friends and family. When professionals can communicate the dangers of spanking in a non-shaming and non-judgmental way, they can shift parents' perspective, which leads to healthier outcomes for children. This workshop introduces a promising and simple program, No Hit Zones, for changing social norms related to spanking/hitting of children. The presentation provides resources for attendees to pitch and successfully launch a No Hit Zone.

In the wake of the killings of George Floyd, Ahmaud Arbery, Breonna Taylor, and others, there have been many calls to "defund the police" and abolish the child welfare system, including the courts, as part of a strategy to eliminate longstanding racial disparities. Meanwhile, Black children continue to suffer disproportionately higher rates of maltreatment and fatalities than their peers as some professionals "screen out" calls of suspected abuse, excuse physical punishment as intrinsic to Black parenting culture, and opponents continue to push back against prevention efforts such as "No Hit Zones," public health education on Adverse Childhood Experiences (ACES), and campaigns to eliminate corporal punishment in homes and schools. Those advocating on behalf of maltreated children often ask, "How do we foster resilience in youth so they can rebound from trauma and grow in the face of adversity?" But while resilience, grit, and the ability to bounce back are understandably seductive, it is a misguided approach to child abuse prevention. The real resilience must come from advocates and professionals who need to shift the responsibility off child victims and work to ensure that holistic, culturally responsive systems and protective factors are in place for families and communities so that children do not have to shoulder the burden of adapting to intergenerational traumas.



PROMOTING RESILIENCY THROUGH TRAUMA INFORMED DESIGN

Child maltreatment, such as emotional abuse or neglect, sexual abuse, or physical abuse, can have profound negative impacts on children, interfering with critical developmental processes and contributing to high levels of clinical need in this population. Trauma-informed approaches to care aim to promote healing environments for traumatized youth across service settings, such as children's advocacy centers, schools, and treatment facilities. However, the focus of trauma-informed care remains on the implementation of services, and has yet to be systematically applied to the physical environment in which these services are delivered. The emerging field of trauma-informed design applies trauma-informed care principles to the design of the built environment, including architecture, interior design, landscape design and user experience. Early research points to the potential for the built environment to not only reduce re-traumatization in vulnerable youth, but also promote resiliency following traumatic experiences (Kopec & Harte, 2020). This poster presentation will provide a preliminary review of the literature on trauma-informed design to facilitate an understanding of emerging best practices and showcase several case studies that demonstrate the potential impact of this work.
